Please inform your Heritage Committee that Tourism Simcoe County will once again be hosting Doors Open Simcoe County in 2020, and I am gathering a list of potential locations. The theme this year is "Environment" and our event will be held on Saturday, September 26th from 10:00AM to 4:00PM.

As a first step, I am looking for your help to identify (and hopefully connect me with) potential Doors Open locations in your communities. Any help you can provide would be appreciated.

What is Doors Open Ontario?

Doors Open Ontario is an annual cultural tourism initiative administered by the Ontario Heritage Trust. The Trust works with communities and partners to open the doors, gates and courtyards of their unique and most fascinating cultural sites to encourage Ontarians to discover the stories inside these exceptional spaces, in communities all across the province. From historical houses to modern marvels of construction, Doors Open Ontario showcases the buildings, natural spaces, infrastructure and cultural landscapes that shape and define our communities.

Selecting Properties

The range of suitable Doors Open Ontario heritage sites is varied and can help participants expand their understanding of heritage properties. It should include sites and buildings that are, and have been central to, the character of your community. Examples could include: commercial buildings, places of worship, cemeteries, inns, schools, Indigenous sites, factories, theatres, boats, gardens, museums, fire halls, railway stations, lighthouses, sports complexes, observation towers, private galleries, civic buildings, lookouts, jails, industrial sites and private homes. Event coordinators are also encouraged to incorporate natural heritage sites and trail systems into their events, where possible. Remember, that admission to these properties must be free on the day of Doors Open Simcoe County.

Historic Simpson House to be fully reconstructed after unauthorized demolition

Main Street Clock Inc. to rebuild and is penalized \$200,000

NEWMARKET, Ontario, January 20, 2020 – The historic Simpson House will be fully reconstructed by the developer, Main Street Clock Inc. (MSC Inc.), who will also be penalized \$200,000, after an unauthorized demolition. MSC Inc. has accepted a stringent set of conditions imposed by the Town of Newmarket to ensure the rebuild of the historic Charles Hargrave Simpson House, at 184/186 Main Street South (Simpson House) in a heritage fashion, as well as the completion of renovations to other associated properties (188/190/192 and 194) on Main Street.

The conditions include:

- A commitment that the Simpson House will be fully reconstructed by MSC Inc. in a full heritage restoration, acceptable to the Town of Newmarket. Other associated properties, (188/190/192 and 194 Main Street), that are part of the development must also be completed according to approved plans and permits.
- A letter of credit in the amount of \$300,000 to secure the completion of the Simpson House reconstruction and completion of work on other associated properties (188/190/192 and 194 Main Street) to the Town's satisfaction and to the full satisfaction of the Chief Building Official and the Town's Heritage consultant.
- Penalty payment of \$100,000 by MSC Inc. to the Town.
- Withdrawal of Community Improvement Plan (CIP) funding of \$100,000 by the Town that would have been provided to MSC Inc. for the entire project under the previous agreement.
- · Acknowledgement of unauthorized demolition by MSC Inc.

"The imposed conditions demonstrate our unwavering commitment to heritage preservation and sends a message that if our community's history and heritage is not respected there will be significant consequences," says Newmarket Mayor John Taylor. "Given the circumstances, this is a positive outcome for downtown and Newmarket as a whole. Our main objective is to protect our heritage and continue to move forward with the development and revitalization of our Main Street."

After the unauthorized demolition of the Simpson House by MSC Inc. in October, the Town immediately launched an investigation and issued stop work orders and compliance orders under the Building Code Act. The original scope of work and conditions for the building permits were only to conduct interior alterations to the Simpson House building. During the Town's investigation, the developer MSC Inc. acknowledged the unauthorized demolition of the Simpson House.

MSC Inc. has provided the following statement regarding its actions:

"Main Street Clock Inc. acknowledges and regrets that the Simpson Building was taken down without proper permissions. We accept the penalties and conditions being imposed by the Town and we are committed to a full heritage rebuild and the completion of the adjacent restorations."

The Town of Newmarket continues to stress the importance of following proper processes and respecting the rules and regulations that are in place under the Ontario Building Code Act and the Ontario Heritage Act.

A detailed information report outlining the investigation process and actions undertaken by the Town will be coming forward to Newmarket Council on February 3, 2020. For more information, including a backgrounder on the MSC Inc. development, please visit newmarket.ca/clocktower

The Charles Hargrave Simpson House is a significant heritage property located at 184/186 Main Street South and was home to Ontario's first female druggist, Anne Mary Simpson, who ran an apothecary at that location from 1886 to 1914.

Newmarket's Simpson House to be reconstructed after unauthorized demolition

Main Street Clock Inc. has agreed to fully reconstruct the historic Charles Hargrave Simpson House at 184/186 Main Street South after demolishing it without permission in October 2019.

The original scope of work and conditions for Main Street Clock's building permits for the property were to make interior alterations to the

building only. However, the Town of Newmarket was made aware of the destruction of the building early October and issued a Stop Work Order on all of the buildings related to the development, comprising 188, 190, 192 and 194 Main Street in addition to the 184/186 property.


Following an investigation by the Town, Main Street Clock has agreed to a full reconstruction and heritage restoration of all the affected properties and payment of a \$200,000 penalty to the Town.

Newmarket Mayor John Taylor issued a statement noting "the imposed conditions demonstrate our unwavering commitment to heritage preservation and sends a message that if our community's history and heritage is not respected, there will be significant consequences."

Main Street Clock provided the following statement
