4.1 Report from the Director of Finance regarding Municipal Act, 2001, O.Reg. 284/09 – Budget Matters.

We received Report No. GGF-2017-15 from the Director of Finance, under date of April 12, 2017 regarding Municipal Act 2001, O.Reg. 284/09 – Budget Matters.

4.2 Report from the Director of Finance regarding 2017 Operating & Capital Budget.

We received Report No. GGF-2017-16 from the Director of Finance, under date of April 12, 2017 regarding 2017 Operating & Capital Budget.

The Director provided an overview of the 2017 Budget and highlighted the portion funded by taxation resulting in an average 2.62% taxation increase; however, it was noted that this will vary depending on property class and assessment.

That 2017 Operating and Capital Budget Report No. GGF-2017-16, be received and that the following recommendations as outlined in the report be approved:

 Transfer from reserves \$ 4,103,719

 Transfer from development charges fund \$ 1,300,300
- (b) That the 2017 total capital expenditures in the amount of \$13,401,302 be approved.
- (c) That the 2017 budget as amended, be approved and that staff are hereby directed to proceed with the preparation of the tax rate by-law for 2017.
